- **NO DRIVING ON BAY WALK FROM OCEAN BREEZE TO OCEAN ROAD**
- **FREIGHT ACCESS FROM OCEAN BREEZE AND BAYBERRY WALK**
- **FAILURE TO OBEY RULES AND RESTRICTIONS WILL RESULT IN A FORFEITURE OF PERMIT WITH NO REFUND**
